Social Justice Isn't What You Think It Is Michael Novak, Paul Adams, 2015-11-03. What is social justice? For Friedrich Hayek, it was a mirage, a meaningless ideological incoherent vacuous cliché. He believed the term should be avoided, abandoned, and allowed to die a natural death. For its proponents, social justice is a catchall term that can be used to justify any progressive-sounding government program. It endures because it venerates its champions and brands its opponents as supporters of social injustice and thus as enemies of humankind. As an ideological marker, social justice always works best when it is not too sharply defined. They stress not individual or state but the vast social space between them. Left and right surprisingly meet. In this surprising reintroduction of its original intention, social justice represents an immensely powerful virtue for nurturing personal responsibility and building the human communities that can counter the widespread surrender to an ever-growing state.

*The Church and Employment Law* John Duddington, 2022-12-16. This book examines the current law on the employment status of ministers of religion, together with religious workers and volunteers, and suggests reforms in this area of the law to meet the need for ministers to be given a degree of employment protection. It also considers the constant theme in Christian history that the clergy should not be subject to the ordinary courts and asks whether this is justified with the growth of areas such as employment law. The work questions whether it is possible to arrive at a satisfactory definition of who is a minister of religion and, along with this, who would be the employer of the minister if there was a contract of employment. Taking a comparative perspective, it evaluates the case law on the employment status of Christian and non-Christian clergy and assesses whether this shows any coherent theme or line of development. The work also considers the issue of ministerial employment status against the background of the autonomy of churches and other religious bodies from the State, together with their ecclesiology. The book will be of interest to academics and researchers working in the areas of law and religion, employment law, and religious studies, together with both legal practitioners and human resources practitioners in these

areas     Engaging the Doctrine of Marriage Matthew Levering, 2020-08-12 This book is the next volume in Levering's Engaging Doctrine series. The prior volume of the series examined the doctrine of creation. The present volume examines the purpose of creation, the marriage of God and humans. God created the cosmos for the purpose of the marriage of God and his people, and through his people, the marriage of God and the entire creation. Given that the central meaning or prime analogue of marriage is the marriage of God and humankind, the study of human marriage needs to be shaped by this eschatological goal and foregrounded as a dogmatic theme. After a first chapter defending and explaining the biblical witness to the marriage of God and his people, the book explores various themes: marriage as an image of God, original sin as the fall of the primordial marriage, the cross of Jesus Christ and marital self-sacrificial love, the procreative and unitive ends of marriage, marriage as a sacrament, and marriage's importance for social justice and for the upbuilding of the kingdom of God. Along the way, the book provides an introduction to the key biblical, patristic, medieval, modern, and contemporary thinkers and controversies regarding the doctrine of marriage.

**The Indissolubility of Marriage** Matthew Levering, 2019-05-20 This well-researched book explains why the Catholic Church continues to teach marital indissolubility and addresses the numerous contemporary challenges to that teaching. It surveys the patristic witness to marital indissolubility along with Orthodox and Protestant views as well as historical critical biblical exegesis on the contested biblical passages. It also surveys the Catholic tradition from the Trent through Benedict XVI and examines a Catholic argument that the Catholic Church's teaching can and should change. Then it explores *Amoris Laetitia*, the papal exhortation from Pope Francis on marriage and the various major responses to it with the issue of marital indissolubility at the forefront. Finally, it retrieves Aquinas's theology of marital indissolubility as a contribution to deepening current theological discussions. The author argues that *Amoris Laetitia* upholds the traditional Catholic teaching that a valid and consummated Christian marriage is absolutely indissoluble in accord with the teachings of Jesus and the Apostle Paul as solemnly and authoritatively taught by the Council of Trent and affirmed by later popes and the Second Vatican Council. He says that *Amoris Laetitia* should be interpreted and implemented in light of the doctrine of marital indissolubility; implementations that undermine this doctrine should be avoided. Levering says that numerous contemporary Catholic theologians and biblical scholars are mistakenly turning the indissolubility of marriage into contingent dissolubility based upon whether the spouses continue to act in loving ways toward each other. The sacrament's gift of objective indissolubility is thereby undermined. Fortunately, the main interpreters of *Amoris Laetitia*, whose views have been approved by Pope Francis, insist that the Apostolic Exhortation does not change the doctrine of marital indissolubility in any way.

Abraham Lincoln's Statesmanship and the Limits of Liberal Democracy Jon D. Schaff, 2019-07-26 This bold, groundbreaking study of American political development assesses the presidency of Abraham Lincoln through the lenses of governmental power, economic policy, expansion of executive power, and natural rights to show how Lincoln not only believed in the limitations of presidential power but also dedicated his presidency to restraining the

scope and range of it Though Lincoln s presidency is inextricably linked to the Civil War and he is best known for his defense of the Union and executive wartime leadership Lincoln believed that Congress should be at the helm of public policy making Likewise Lincoln may have embraced limited government in vague terms but he strongly supported effective rule of law and distribution of income and wealth Placing the Lincoln presidency within a deeper and more meaningful historical context Abraham Lincoln s Statesmanship and the Limits of Liberal Democracy highlights Lincoln s significance in the development of American power institutions and social movement politics Using Lincoln s prepresidential and presidential words and actions this book argues that decent government demands a balance of competing goods and the strong statesmanship that Lincoln exemplified Instead of relying too heavily on the will of the people and institutional solutions to help prevent tyranny Jon D Schaff proposes that American democracy would be better served by a moderate and prudential statesmanship such as Lincoln s which would help limit democratic excesses Schaff explains how Lincoln s views on prudence moderation natural rights and economics contain the notion of limits then views Lincoln s political and presidential leadership through the same lens He compares Lincoln s views on governmental powers with the defense of unlimited government by twentieth century progressives and shows how Lincoln s theory of labor anticipated twentieth century distributist economic thought Schaff s unique exploration falls squarely between historians who consider Lincoln a protoprogressive and those who say his presidency was a harbinger of industrialized corporatized America In analyzing Lincoln s approach Abraham Lincoln s Statesmanship and the Limits of Liberal Democracy rejects the idea he was a revolutionary statesman and instead lifts up Lincoln s own affinity for limited presidential power making the case for a modest approach to presidential power today based on this understanding of Lincoln s statesmanship As a counterpoint to the contemporary landscape of bitter uncivil politics Schaff points to Lincoln s statesmanship as a model for better ways of engaging in politics in a democracy
