**Metals**  
Metallic luster, brittle, fair electrical conductors. All known in semiconducting forms. Moderate ionization energies (700–1,000 kJ/mol), and electronegativity values (1.8–2.2). Usually behave chemically as non-metals. Can form alloys with metals. Amphoteric or weakly acidic oxides.

**Intermediate nonmetals**  
H and N are colorless gases; C, P\*, and Se are metallic luster solids while S is yellow. The latter four are brittle but all known in malleable, plastic or ductile forms. Moderate to high ionization energies, low to high electron affinities, moderate to high electronegativity values, relatively poor to moderately strong oxidizing agents\*, tend to form covalent or metallic to near-metallic compounds with metals.
