Musk Deal To Swell Twitter's Debt Load

Twitter Inc. has struggled for most of its history to make a profit. It now faces a new challenge: its \$44 billion acquisition of the social-media platform, one factor will make that harder: the money he borrowed to fund the transaction.

As part of the deal, Twitter will add about \$12 billion of debt. Analysts estimate, based on terms previously laid out in documents related to the transaction, that Twitter would be on the hook for around \$12 billion, compared with some \$10 million in 2021. Twitter has posted average annual earnings before interest, taxes, depreciation and amortization of about \$700 million over the past five years.

That interest burden means Twitter will need to find ways to make investment gains and expand profit margins, said James Chubb, a senior analyst at credit-research firm Credit Suisse. "There's a pretty big, significant amount of cash," he said.

But some of the biggest debt is expected to be a floating rate, Twitter could end up paying more, according to analysts. *Please turn to page A2*

China Stocks Fall After Xi's Moves

U.S.-listed Chinese stocks plunged to their lowest level in nearly a decade, losing tens of billions of dollars in market value on Monday, one day after President Xi Jinping secured a third term as leader of the Communist Party.

The Hong Kong Golden Dragon China Index, which tracks dozens of Chinese companies listed on American exchanges, fell more than 3% to its lowest close since April 2015.

erasing \$73.4 billion in market cap since Friday's close through Monday, according to Dow Jones Market Data.

The selloff followed a rout in Chinese stocks in Hong Kong and mainland China overnight, with the Hang Seng Index erasing its biggest one-day gain since the global financial crisis.

Stocks in the U.S., by contrast, rose as investors encouraged corporate earnings growth and the hope the price of Federal Reserve rate increases will soon moderate.

The Dow Jones Industrial Average rose more than 400 points, or 1.3%, to its highest level in six weeks. The S&P 500 gained 1.2%, while the technology-heavy Nasdaq added 0.8%.

The broader selling came after Mr. Xi consolidated his support over the ruling Communist Party, stacking the leadership ranks with loyalists and ending his first term.

Financial investors dashed for the exit. The American Depository Receipts of the Dow

largest Chinese stocks lost more than \$52 billion in combined market value.

Chinese Internet and technology stocks were hit especially hard. Alibaba, which traded below \$200, the price at which it went public in its blockbuster 2014 initial public offering, fell 10%.
