


Part 1: Non-Bank Financial Accounting Activities



Proposed activities, which would be non-financial activities, will be those that are not banking or financial activities, such as those of a general nature, such as administration costs, price fixing, the sale of fixed assets, delivery services, the provision of maintenance services, etc. The term "non-bank" may be interpreted as meaning "non-financial" and "non-banking". These activities will not be included in the proposed accounting system for these particular categories of business entities.

Non-financial activities will be grouped into three categories: business, non-business and government, according to their nature and function.

Business activities will be grouped into four main categories: production, distribution, trade and services. These activities will be further subdivided into more specific categories, such as manufacturing, construction, retail trade, wholesale trade, agriculture, forestry, fisheries, mining, quarrying, construction, transportation, communications, energy, accommodation and food service activities, among others.

Non-business activities will be grouped into two main categories: agriculture, forestry, fisheries, mining, quarrying, construction, transportation, communications, energy, accommodation and food service activities, among others.

Government activities will be grouped into three main categories: central government, local government and other government units.
