This would be my first speeding ticket, according to my driving records. I am a cautious driver who always adheres to the speed limit and due to my age (67), I find it unsettling to exceed (50mph). Thus It's extremely unlikely that I was driving too fast.

I humbly request that my speeding ticket be dismissed. Since it will result in an increase in my insurance rate, which I cannot afford.
