Leading at the intersection: The CEO's changing role

"Over business was imperious. You could operate and the world around you could be a vortex of activity, but you could just keep going. Now, with the combination of all the factors at play, business and what's happening outside are actually one."

The roles of the world's executives gained global prominence in the wake of the recent high-profile CEO resignations, suggesting the need to assess how many business leaders respond when they reflect on the nature of their roles and the leadership challenges they face. Indeed, three quarters of the CEOs we interviewed said the job has changed significantly over the past decade as new pressures have forced the organization to compete with the external world on issues such as diversity, sustainability, employee, and customer.

To be sure, the CEO role is still the top of the leadership stack, but also the most in flux. CEOs sit at the intersection of an increasingly complex and interconnected world: no longer the organization and its stakeholders, but also the public and the world. CEOs must manage public, geopolitical, social, natural disaster, government, employee, customer, and a digitally empowered public that is now CEO's number one stakeholder. "How do you manage transparency [or] put back transparency and be the same time make that an everything has to be said, but everything isn't important has to be said?"
