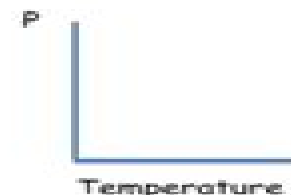
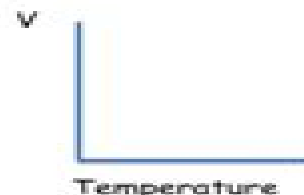


Bouncing off the Walls PhET Gas Law Simulation 2013

c) number of particles on pressure; d) temperature on pressure.

COLLECTING DATA

PART 1: Effect of Volume on Pressure

1. Hit the reset button.
2. In the upper left corner under "Constant Parameters", select "Temperature". This will keep the temperature relatively constant. Set the number of particles to a constant value.
3. To measure the volume, hit the button "Measurement Tools" and select the "Ruler". The ruler can be moved so you can measure the size of the box to get a measurement of volume.
4. Take 5 separate measurements over a large range of numbers without exploding the container.
