ON 021921 I TALKED WITH SERGEANT GROAT #6179 REFERENCE THIS INCIDENT TO CLARIFY WHO HE WAS CONTACTING AFTER WATCHING HIS BODY WORN CAMERA. THE CAMERA STARTED RECORDING ON OCTOBER 17, 2020 AT 2005 HOURS AND THE FOLLOWING IS A SUMMARY OF WHAT WAS LEARNED.

AT APPROXIMATELY 1:57 MINUETS INTO THE FOOTAGE SERGEANT GROAT OBSERVED A GROUP OF PEOPLE IN THE ROADWAY POINTING STROBE LIGHTS IN THE DIRECTION OF HIS VEHICLE. AN ANNOUNCEMENT WAS MADE FOR THE GROUP OF PEOPLE TO VACATE THE ROADWAY AND IT WAS MADE ONE MORE TIME AT 2:19 MINUETS INTO THE FOOTAGE. DURING THIS CONTACT SERGEANT GROAT ADVISED THERE IS A MALE WITH A BACKPACK THAT CROSSED THE ROAD. THIS INTERACTION WITH THE GROUP WAS MARKED BY SERGEANT GROAT IN THE FOOTAGE.

AT APPROXIMATELY 30:00 MINUETS INTO THE FOOTAGE SERGEANT GROAT OBSERVED A GROUP OF 15-20 PROTESTERS IN THE ROADWAY WITH UMBRELLAS AND STROBE LIGHTS SHINING THEM AT VEHICLES. SERGEANT GROAT YELLED TO THIS GROUP OF PROTESTERS TO GET OUT OF THE ROADWAY. AS THE PEOPLE WERE ON THE SIDEWALK SERGEANT GROAT YELLED TO OFFICER BILLINGSLEA #7917 ABOUT A GUY WITH A GRAY BACKPACK AND REFERRED TO OFFICER BILLINGSLEA AS "SPIDER" IN THE VIDEO. IN THIS PART OF THE VIDEO AT 30:49 SERGEANT GROAT MENTIONS GRAY BACK PACK AND AT 31:17 SERGEANT GROAT ADVISED A GUY IN THE CROWD IS A LEGAL OBSERVER FROM FROM AN EARLIER ENCOUNTER. SERGEANT GROAT DID NOT POINT TO RYDER COLLINS AND THE IDENTITY OF THE MALE FROM THE EARLIER INCIDENT IS STILL UNKNOWN AT THIS TIME. THE PERSON WHO SERGEANT GROAT REFERRED TO FROM BEING RECOGNIZED DURING THIS PART OF THE VIDEO IS FROM THE EARLIER INCIDENT.

RYDER COLLINS WAS WEARING A GRAY SHIRT WHEN HE WAS ARRESTED AND THE UNKNOWN MALE FROM THE EARLIER INCIDENT WAS IN A BLACK SHIRT.

Williams, 2008 Negative sentiment regarding conducted energy weapons is due largely to a lack of understanding about the technology behind such weapons and a misunderstanding of those weapons' physiological effects Media accounts that speculatively associate sudden in custody deaths with the use of conducted energy weapons only add to the confusion **TASER ELECTRONIC CONTROL DEVICES AND SUDDEN IN CUSTODY DEATH** documents 310 deaths in the United States proximate to the application of TASER electronic control devices from 1983 through 2006 The study examines the phenomenon of sudden death as it relates to electromuscular disruption technology and TASER electronic control devices by constructing 213 cases studies dating from 1983 through 2005 and analyzing information available from news accounts police reports and autopsies After reviewing the available evidence from this extensive case study the author concludes that these conducted energy weapons are excluded as the cause of death in 182 of the 212 cases In only two cases did the evidence tend to confirm the weapon was either a cause of death or a significant contributing factor While arguing that the TASER electronic control devices are safe less lethal weapons the author also cautions that they are not completely effective He notes that the weapons were not effective in subduing more than 60 percent of violent or aggressive subjects in the 213 case studies and he documents 131 cases of fatal police shootings and one police fatality following the failure of the weapons The only way to determine whether the TASER electronic control devices is responsible for deaths is to separate evidence from conjecture and analyze the facts of each case This book will be an excellent resource for law enforcement professionals attorneys investigators and criminal justice personnel *Task Force Report* United States. Background: The Fast and Furious operation was responsible for allowing approximately 2,000 firearms to illegally flow into the hands of criminals, including Mexican drug cartel associates. On December 14, 2010, Customs and Border Patrol Agent Brian Terry, a United States Marine, was killed while on patrol just miles from the Mexican border. The firearms found at the scene were semi-automatic rifles that were allowed to walk as part of Operation Fast and Furious. Congressional Republicans have investigated Fast and Furious since January 2011. Over the course of the investigation, the Justice Department has provided false information, stonewalled document requests, produced scores of blacked-out pages and duplicate documents, and refused to comply with two congressional subpoenas.
