Since the original publication of TEXAS LITIGATION GUIDE, the Texas Legislature has been engaged in an ongoing process of codification of various articles of the Revised Civil Statutes into codes organized by subject matter. In addition, the Supreme Court has replaced the Texas Rules of Civil Procedure that governed appellate practice with the Texas Rules of Appellate Procedure (T.R.A.P.). Any revisions of statutes or rules that are substantive in nature have been incorporated into replacement pages and this cumulative supplement. As pages in this volume are replaced, the citations to former articles and superseded rules will be replaced with the current citations.
