## The War in Iraq



- In November, Saddam Hussein allowed UN weapons inspectors to resume their search for weapons of mass destruction in Iraq.
- Two months later they reported finding no banned weapons.
- Despite this report and lack of support from several key allies, President Bush declared war on Iraq.
- The war began on March 19th, 2003.
- Three weeks, later American tanks arrived in the Iraqi capital, Baghdad.
- Later that year, Bush declared the War in Iraq over, though many of the toughest battles were still to come.
