## → STOCKHOLDERS EQUITY (A.K.A. RESIDUAL INTEREST OF A CORPORATION)

#### Corporate Capital

Three primary forms of business organization

- 1. Proprietorship (including LLCs)
- 2. Partnership (including LLPs)
- 3. Corporation (public or private)

#### Special Characteristics of Corporations

- They are subject to corporate state law from they are incorporated in
- Use capital stock or share system
- Can possess a variety of ownership interests (i.e. common, preferred stock)

#### State Corporate Law

- Corporation must submit articles of incorporation (charter) to state in which incorporation is desired
  - Incorporated in one state, doesn't have to be the state the headquarters are in
- Most corporations incorporate in Delaware
  - Its state laws favor the corporate form of business organization

#### Capital Stock of Share System

→ Each corporation has a large number of units or shares of stock authorized by its charter

- Corporations may have more than one type/class of stock (common, preferred)
- Within each stock class, each share equals exactly to every other share
- Number of shares possessed determines the owner's interest
  - If you own 250 of 1000 shares you own 25% of company
- The share system easily allows transfer of ownership interest from one investor to another at any time, at any price, without obtaining consent

→ each share of stock has certain rights and privileges, which can only be restricted by a Corporation via a special contract:

- 1. To share proportionately in profits and losses
  - You own 25% of the corporation's ownership interest, you stand to lose 25%
- To share proportionately in management (the right to vote for directors)
- 3. To share proportionately in assets upon liquidation
- To share proportionately in any new issues of stock of the same class—called preemptive right
  - If you own 25% before new stock is issued, you have the right to stay at 25% after the issuance of new stock.

#### Variety of Ownership Interests Common Stock:

- Represents basic corporate ownership or residual interest
  - Bears the ultimate risk of loss if Corporations do not do well
  - o. Dividends are not guaranteed
  - Assets upon dissolution are not guaranteed
  - Profit the most if Corporation is successful
  - Generally control management through board of directors' elections

#### Preferred Stock

- Created by contract—with rights and privileges that are different from common stock
- Usually issued with par value and a percentage that represents what preferred stock is entitled to when dividends are paid out
  - 10% preferred stock with \$200 par is entitled to an annual dividend of \$20 per share

#### Unattractive Rights and Privileges

- No voting -cannot vote like common stockholders do

#### **Attractive Rights and Privileges**

- 1. Preference to dividends
  - If a dividend is declared by a corporation, preferred stockholders must get paid the stated dividend rate BEFORE paying dividends on common stock
  - b. Special features regarding dividend payments
    - i. Cumulative: if a corporation fails to pay a dividend in any year, the dividend amount will accumulate every year until paid (called "dividends in arrears")
    - Non-Cumulative: above feature does not exist. Dividends not declared in a given year are lost forever
