- per incuriam (wrongly decided because it has missed out a relevant statutory provision or case)
- Reversed vs. overruled
  - Means an appeal has been made from earlier decision
  - Means the ruling/statement of law in an earlier case has been invalidated. The decision in the earlier case is unaffected. E.g. *Hedley Byrne and Candler v Crane*
