

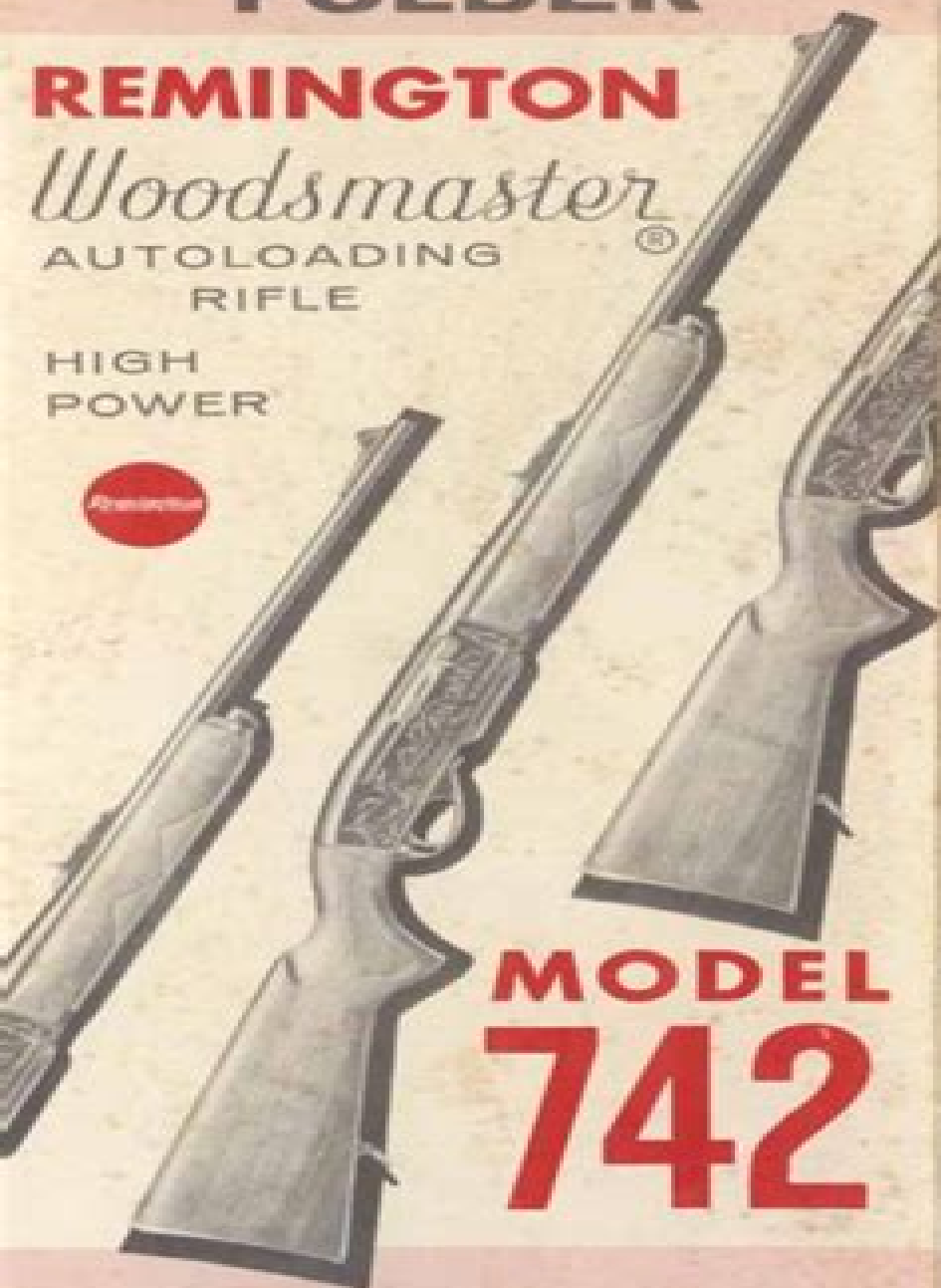

This gas-operated rifle is designed for rugged hunting use, and built to Remington's rigid standards, using quality materials. The Model 742 is take-down in design which means the barrel and action parts can be removed for maintenance and care.

The "Woodsmaster" has a five shot capacity — four in the detachable magazine plus one in the chamber. The trigger must be pulled to fire each round. The action will lock open when last round from magazine is fired. Extra magazines can be easily carried in the pocket for fast reloading.

Proper care after handling and hunting will insure long life and keep your Remington "Woodsmaster" in good shooting condition.

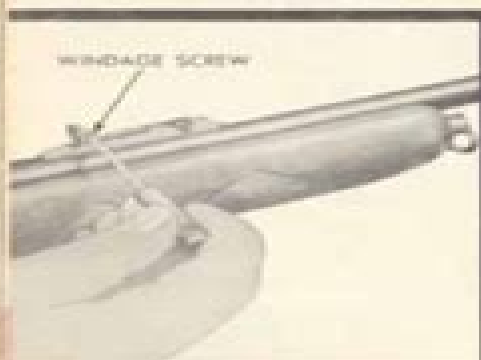
CARE OF RIFLE: Remington guns will remain clean longer and continue to give satisfactory all weather performance if little or no lubrication is used in barrel and action parts. However, when the rifle is returned to warmer room temperatures after cold weather use moisture may form on interior as well as exterior metal surfaces. To remove this moisture wipe barrel bore, barrel chamber, and all breech and action parts and then re-oil sparingly.

Also give exterior surfaces of receiver and barrel attention after hunting. Fingerprints tend to form rust unless wiped away. To remove prints wipe all metal surfaces with an oiled cloth.

SIGHT ADJUSTMENT: Factory sights on Remington high power rifles are targeted at 100 yards and carefully adjusted for average shooters at the factory.

WINDAGE — Move rear sight to left by turning windage screw clockwise. This will move bullet impact at target to left. Turn windage screw counter clockwise to move rear sight to right. Bullet impact will then move to right.

ELEVATION — Bullet impact at target will lift or range increase by raising rear sight. Raise rear sight by sliding notched sight step beneath sight. Bullet impact will drop, or range decrease if sight is lowered.



The all-purpose stock on your Remington rifle is designed for use with telescope or receiver sights as well as factory open sights. Location of rear sight holes is standard for most target telescope mounts. If rear sight is removed for receiver sighting clearance, receiver plug screws, in top panel of receiver, may be used to fill rear sight barrel screw holes.
