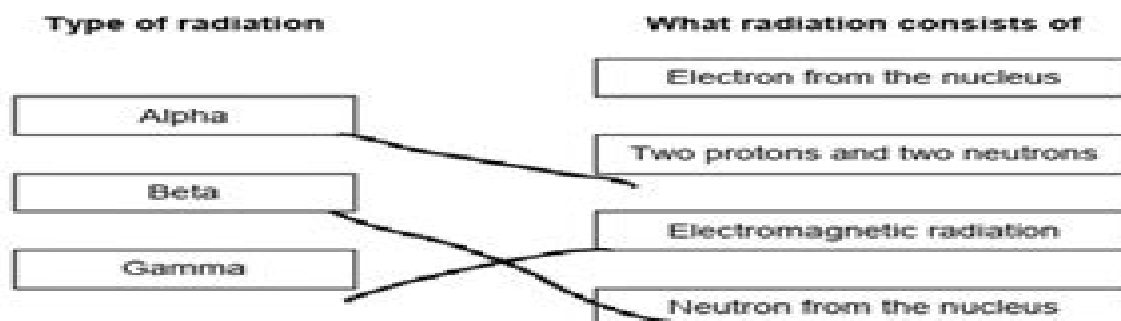

Alpha, beta and gamma are types of nuclear radiation.

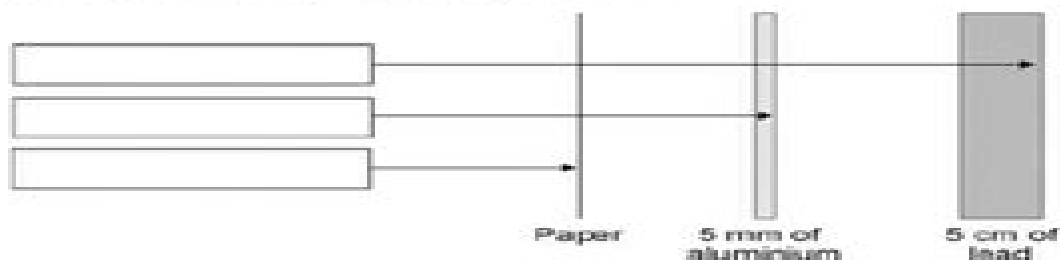
