This book examines the treatment of fidelity rebates as one of the most controversial topics in EU competition law. The controversy arose from the lack of clarity as to how to distinguish between rebates that constitute a legitimate business practice and those that might have anticompetitive effects as the same type of rebates could be pro-competitive or anticompetitive depending on their effects on competition.
