Howard examines activism across generations: first by African Americans seeking to desegregate public housing, then by cross-racial and cross-ethnic tenant groups mobilizing to maintain public housing in the shadow of gentrification. Taken together, the stories Howard tells challenge assumptions about public housing and its tenants and make way for a broader, more productive and inclusive vision of the public housing program in the United States.
